 Parking is a privilege and may be revoked without notice. Lessee understands that it is required to have a valid SAMI parking sticker to be allowed to park in any SAMI lot. Lessee understands that if they sublease their apartment, their subleasor is required to have a valid SAMI parking sticker issued to them either from the SAMI office or from the towing company responsible for that lot. Lessee understands the only payments that can be deferred with fall financial aid for HCC students are the September a October payments. Lessee understands the only payments that can be deferred with spring financial aid for ISU are December and January
payments. 5. Lessee understands the only payments that can be deferred with spring financial aid for HCC are March and April
payments. 6. Lessee understands the rent must be paid immediately once they receive their financial aid.
