SAMI PARKING STICKER INSTRUCTION/POLICIES

The only vehicles authorized to park in the parking lot for the building in which I live are the properly registered vehicles of the tenants. A properly registered vehicle is one in which a current, valid parking sticker is affixed in the lower left (drivers side) corner of the rear window, and the sticker is registered to the make, model, year and license plate of the vehicle that is in the parking lot. The entire parking sticker must be visible when standing at the rear of the vehicle in order to be valid in the lot. If you have heavily tinted windows, a pickup truck with a topper, or a convertible top, the sticker should be placed in the front windshield on the passenger side, 5 inches from the bottom of the windshield and the top of this form must be marked 'Front Window'. The parking sticker comes with its own adhesive, and if properly applied to the window it will not fall off. The use of tape or other product to secure the sticker could cause the sticker to fall off the window, therefore subjecting the vehicle to tow (this includes if the sticker is laying in the front or rear deck of the vehicle). The sticker is not visible or readable through frosted, fogged, snow covered or tinted window if it is not attached to the window and would be subject to tow. Allowing anyone else to use the sticker, or placing the sticker in a vehicle other than the one it is registered to will subject the vehicle to tow. If a parking sticker is found in a vehicle it is not registered to, the vehicle will be towed. If the vehicle that the sticker is registered to is also in the lot, it would also be towed.

This sticker is, and will remain, property of the parking management, and can be voided at any time. Any mutilation of the sticker, in part or whole, or any copying of the sticker, in part or in whole, will AUTOMATICALLY void the sticker.

Both SAMI Realty and Maurer Wrecker will retain records of the registered vehicles, and Maurer Wrecker must be notified, in person, of any changes in the vehicle to which the sticker is registered. Each sticker will cost \$10 that you must pay upon registering your vehicle with management. To have a sticker switched to a new vehicle, or have a new sticker issued, both the registration for the new vehicle, and a drivers license are required. Sticker changes will have a charge of \$10 per change. Maurer Wrecker must be notified of a lost or stolen sticker. Replacement of a lost sticker requires a drivers license, registration for the vehicle, and a \$10 lost sticker fee. Parking a registered vehicle in the lot without a visible parking sticker could result in the vehicle being towed. The parking sticker gives no guarantee of a parking space. If at any time there are no parking spaces available, and you have a valid, current parking sticker, you must notify Maurer Wrecker of the parking problem. Maurer Wrecker can be reached 24 hours a day at (309) 376-3731. **UNDER NO CIRCUMSTANCES does this parking sticker allow anyone to park in the following areas: grass/mud/dirt, drive or yard, double-parked in the middle of the lot, blocking the drive or blocking the dumpster.** These areas are immediate tow-away zones, with or without a parking sticker.

Every vehicle requires a valid parking sticker to park in the lot. Any vehicles in the lot without stickers are subject to tow. Upon termination of residence at the apartment, the parking sticker MUST be surrendered to management either in person or by mail. Visitor parking rules and regulations can be acquired by the management and you are responsible for your visitors' vehicles.

INITIAL:

I understand all of the information given above, and I understand that failure to comply with these instructions/policies could result in the voiding of the parking sticker, loss of parking privileges and/or my vehicle or the vehicle of a guest being towed. It is my responsibility to notify all guests of these parking policies.
